### The Homelessness Reduction Act

(HRACT) received Royal Assent on April 27, 2017. The Government has now decided that the new legislation must be in place by April 2018.

We are told that during the transitional period DCLG advisers will actively provide support and advice to local authorities to help them prepare.

Additional funding has also been ring-fenced to help cover implementation costs.

The Act fundamentally changes the homelessness legislation by introducing a statutory duty to help prevent applicants from losing their home and requiring action to help secure accommodation for applicants who are homeless. The new duties are 'blind' to whether an applicant has a priority need.

Local authorities have an excellent record for working successfully to prevent homelessness. However, there will be a need to look at wider Housing Options Structure, Triage arrangements and review the approach to prevention and working processes.

All Housing Options staff and other relevant teams will need to be fully trained on the new law, the prevention duties and how to implement the many other changes that the Act will make to the way the Part 7 statutory tests are assessed and applied.

Locata has worked with housing consultant Andy Gale to develop a brand-new set of Preventing Homelessness toolkits to help local authorities prepare for the changes.
